



## SHIPPER DECLARATION OF VALUE

### **BASIC/STANDARD VALUE Coverage - \$.60 per pound**

A HOUSEHOLD GOODS CARRIER'S LIABILITY FOR LOSS OR DAMAGE TO ANY SHIPMENT IS \$.60 PER POUND PER ARTICLE, UNLESS THE CARRIER AND SHIPPER AGREE IN WRITING, TO A GREATER LEVEL OF LIABILITY. The value of my shipment is \$\_\_\_\_\_. (Client must write 60 cents per pound). Maximum coverage limit for this insurance is \$300 at no additional charge. Boundless Moving & Storage reserves the right to repair any damaged goods in lieu of reimbursement or replacement. Shipper understands that coverage for walls and floors is limited to \$50.00 per contract.

### **PARTIAL VALUE PROTECTION: Replace or Repair - \$500 Deductible** **This Is Not Insurance**

I understand this option is not insurance – it provides coverage based on the current replacement value at time of loss or damage and that I will have a \$500 deductible for the entire shipment. I declare a total value of \$\_\_\_\_\_ or a minimum of \$5,000 dollars per room at origin (each 5' x 5' of storage space will constitute a room). I understand that the total reimbursement for lost or damaged goods shall not exceed this declared value. Boundless Moving & Storage reserves the right to repair any damage goods in lieu of reimbursement or replacement. Additional cost is an additional charge of \$199 per \$50,000 of declared value, per truck. Under Partial Valuation, carrier's liability will not exceed \$10,000 for the entire shipment. Shipper understands that coverage for walls and floors is limited to \$125 per contract.

### **FULL VALUE PROTECTION: Replace or Repair - \$0 Deductible** **This Is Not Insurance**

I understand this option is not insurance – it provides coverage based on the current replacement value at time of loss or damage and that I will have a \$0 deductible for the entire shipment. I declare a total value of \$\_\_\_\_\_ or a minimum of \$5,000 dollars per room at origin (each 5' x 5' of storage space will constitute a room). I understand that the total reimbursement for lost or damaged goods shall not exceed this declared value. Boundless Moving & Storage reserves the right to repair any damage goods in lieu of reimbursement or replacement. Additional cost is an additional charge of \$399 per \$50,000, per truck. Under Full Value Protection the carrier's liability will not exceed \$50,000 for the entire shipment. Shipper understands that coverage for claims to walls and floors is limited to \$250 per contract.

- Prior to the move the shipper must select one of the options listed above. If shipper refuses to select one of these options, the carrier will not be required to perform the move.
